- 1 None of this means that I killed Kieran. I did not kill my friend
- 2 Kieran.
- 3 After that argument on July 16, I wasn't in the best mood. Later
- 4 on in the afternoon, around 1:00 PM, Kieran and I were setting
- 5 up in the meeting space. I was notified that hotel staff were
- 6 having problems with the projection screens and they weren't
- 7 sure if they'd be able to fix them in time for the meeting. I lost
- 8 my temper and walked out of the meeting space with Kieran
- 9 right behind me. I said something like "if this doesn't get fixed
- there's going to be a bloodbath." I was referring to the hotel
- staff's constant problems, but even then, I know my outburst
- was unnecessary. I saw Arian and Gerri standing in the hallway
- outside and I told them that the hotel staff was incompetent. It
- 14 felt like I was more upset and worried about the board meeting
- 15 the next day than Kieran was. I don't know where Kieran went
- at that point, but that was the last time I ever saw Kieran.
- 17 I spent the rest of the day in my hotel room taking conference
- calls and preparing for the board meeting. By the end of the day
- 19 I was mentally drained. A good run on the treadmill always
- 20 helps me clear my head. So, I went to the hotel's 24-hour gym. It
- 21 was around 11:00 PM. I headed towards the stairs and didn't
- see anyone else in the hallway at that time. There was no one
- 23 else in the gym with me. [[At some point while I was in the gym,
- 24 I noticed my phone battery was dead. I do not know when it
- 25 would have died.]] After I worked out, finished my stretching
- routine, and finished by post-workout meditation, I went back
- 27 to my hotel room a little before 1:00 AM. I was exhausted and
- went straight to bed. I was so tired I didn't even charge my
- 29 phone. I never went anywhere near Kieran's suite that night.
- 30 I left the hotel very early on the 17th, around 5:00 AM. I couldn't
- 31 bear being at the board meeting. I didn't want to stand there
- and watch while Kieran lied to everyone in the room. I figured it
- 33 would be better if I just removed myself from the situation. To
- 34 occupy my mind, I ran errands all morning. I took all of my
- 35 clothes to the dry cleaner. I cleaned my car. I felt a lot calmer by
- noon. I decided I was going to withdraw the patent application
- 37 for ForeverFlex and resign from SMC.
- 38 At around noon, I charged my phone and saw I had three or
- 39 four voicemails from Arian. I listened to the first one, and Arian
- 40 told me that Kieran had been found dead in Kieran's suite,
- 41 apparently stabbed. I was absolutely devastated. Who could do
- 42 something so brutal and so senseless? No one I know hated
- 43 Kieran.

- When Detective Perren called me and asked me to come down to the station on the 19th to talk about Kieran's death, I agreed.
- 3 I felt uneasy, like the detective thought I was a suspect, so I
- 4 brought my lawyer with me. You know what they say: a lawyer
- 5 who represents themself in a case has a fool for a client. I told
- 6 the detective about the meeting I had with Kieran on the
- 7 morning of July 16 and how I had given Kieran a bottle of
- 8 champagne and a saber. I described that Kieran was wearing a
- 9 black two-piece suit, a white collared shirt, and a gray tie. I also
- told the detective that the argument Gerri likely overheard was
- 11 most likely about how Kieran surprised me by sharing that the
- 12 FoverFlex was a flop and that Kieran was planning to lie to the
- board. I told the detective I had no idea about the problems with
- 14 the product until the morning of July 16.
- 15 I provided my fingerprints and a DNA sample to the detective. I
- did so voluntarily because I had nothing to hide. Later I learned
- 17 that my fingerprints matched those on the saber. I wasn't
- 18 surprised because I had handled it that day as I was showing it
- off to Kieran. And as for the Magnates shoes the police were
- 20 looking for, I had donated them months ago. They were really
- 21 worn out.
- When the detective later showed up at my home with a search
- 23 warrant, I was shocked. I couldn't believe that I was a suspect
- in this case. On August 3rd, Detective Perren returned to my
- 25 home and arrested me for the murder of Kieran Sunshine. I was
- surprised to be arrested for Kieran's murder. I would never do
- 27 anything to hurt my friend. Whatever difficulties we were
- 28 having because of business, I knew deep down that we would
- 29 be friends again someday. I guess now we won't have the
- 30 chance.
