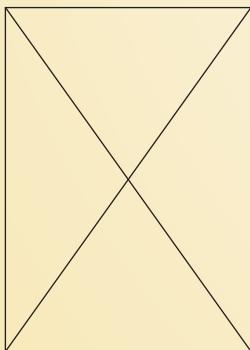

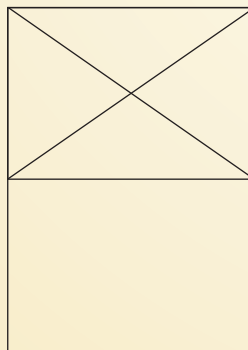

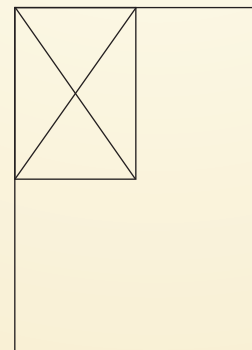
Full Page
